

Petoskey Pop Warner Football Association VOLUNTEER & EQUIPMENT BONDS AGREEMENT

The Petoskey Pop Warner Football Association (PPWFA) requires the following bonds for the 2023 Season.

Volunteer Bond	Equipment Bond
\$150 per family	\$60 per player OR \$80 per family (2 or more children participating)

Bond deposits (2, one per bond type) are due prior to any distribution of uniforms or equipment to our participant(s). These deposits <u>are REFUNDABLE</u> at the end of the season if the following conditions are met:

VOLUNTEER BOND CONDITIONS

Successful completion of ONE of the following:

- 1. Complete mandatory number of shifts PER FAMILY during home games by working in either the Concession Stand, 50/50, Chain Gang, Front Gate Ticket Booth or other Board approved volunteer opportunities.
 - 1 child participant: Two Shifts PER FAMILY
- 2 or more children participants: Three Shifts PER FAMILY

It is the sole responsibility of each family-designated volunteer to <u>sign-up for times and dates</u>, <u>Fulfill the duties</u> on the date and time hereby agreed to, and <u>Sign-In to receive credit for work performed</u>.

- 2. Serve on an eligible PPWFA committee during the current season in which your child plays Pop Warner.
- 3. Serve as a Head Coach or Board Member during the current season in which your child plays Pop Warner.
- 4. For a \$150 donation, the two (2) mandatory shifts per family will be waived.

EQUIPMENT BOND CONDITIONS

Successful completion constitutes the return of ALL uniforms and equipment as per the Equipment Rental Checklist and Equipment Rental Agreement. (A participant may only play in Board-approved equipment).

There will be no reimbursement for partial return of equipment. Any loss or damage to equipment, beyond normal wear and tear, will be assessed a repair and/or replacement fee as estimated on the Equipment Rental Agreement.

If ALL EQUIPMENT IS NOT RETURNED BY OCTOBER 31 of the current season, your entire Equipment Bond deposit amount will be forfeited. The forfeiture of this deposit shall not prevent PPWFA from the further collection of equipment, or any sums owed in excess of the deposit PLUS any additional collection expenses, court costs, and reimbursement for time spent in our efforts to retrieve it.

No equipment will be accepted after DECEMBER 1 of the current season. At that time if equipment has not been returned, you will be billed for the ENTIRE replacement costs of missing equipment as per the most current Equipment Rental Agreement PLUS any additional collection expenses, court costs, and reimbursement for time spent in our efforts to retrieve it.

I understand that my Volunteer Bond check, in the amount of \$150, will be returned to me after successful completion of the Volunteer Bond conditions. I understand that my Equipment Bond check, in the amount of \$60 (or \$80 if I have 2 or more children participating), will be returned to me after successful completion of the Equipment Bond conditions. I understand failure to meet successful conditions of a bond results in non-compliance with the above agreement. I understand that the Volunteer Bond check and the Equipment Bond check will be held by the Board of Directors and will not be deposited into any account unless forfeited by the issuer for non-compliance with above agreement.

As the Parent/Guardian of a Participant(s), I acknowledge and agree to the above conditions of the Work & Equipment Bonds Agreement. I understand that if the Participant(s) I registered resigns from PPWFA during the season there will be no refund.
