- d. Playing time minimum requirements & maximum goal differential:  
U9/10 A & B – 50% (35 minutes per game), 6 goals  
U11-U15 A – none, none  
U11-U15 B – 50% (40 minutes per game), 6 goals  
U16+ A & B – none, none  
Playing time exceptions: injury, illness, discipline  
Playing time issues came up in the survey, so keep track please.  
Exceeding maximum goal differential results in a forfeit, fine to the Club, and loss of standings
- e. First game on Saturday, put out corner flags, Last game on Sunday, put them away. They cost about \$150/set and the mowers will destroy them!
