Update with County- Moved to Phase 2- Practice but only in groups of 5. Board will come up with guidelines for practice.

- · Update with registering teams in RegisterUSA- Scott has met with League coordinators. Many birth certificates are still needed. Many coaches still need to fulfill coach requirements. League coordinators will be in touch with these coaches.
- c. Second VP Elizabeth Hostetler- Compiled year end concession reports . Still creating a budget to use as a working budget. She will be finished shortly and share with Nikki and the board.
