ST. JOSEPH CYO PARENTAL AGREEMENT

- 1. My child is eligible to play because he/she either: (1) attends St. Joseph School, (2) is enrolled in St. Joseph's Faith Formation, or (3) resides in the parish's boundaries, which are: north of Scott Creek Road, East of the Union Pacific railroad tracks, south of Stevenson.
- 2. I understand that restrooms will be open during meets and practices. I will instruct my child/children to properly use and to respect the facilities. I understand that CYO is a guest at the facilities, and it is my responsibility to help ensure that the program is able to continue using the facilities by using the locations responsibly.
- 3. When children are dropped off at practice, parents are to make sure that their child's coach is at the facility before the parent leaves. No parent is to leave a child until after the coach arrives. Parents must pick up their child. Children are not to walk or ride a bike home. If a parent wants their child to walk or ride a bike home, the parent is to provide St. Joseph CYO with a letter stating that and releasing CYO from responsibility.
- 4. I understand that parents and family members are welcome to come to practices and watch, but non-CYO players are not permitted to use the facility during a team's practice and may not stay at practice without a parent or guardian. This includes siblings.
- 5. I understand that I can encourage and work with my child at home, but during practices and meets, I may not coach my child unless I am a coach with a coach's card.
- 6. I understand and agree that Coaches coach, runners run, and parents and fans cheer positively and support good play by all teams and will act accordingly at meets.
- I will cheer positively. Runners, parents, and fans MAY NOT heckle, jeer, or taunt officials, coaches, runners or other fans. I will allow the runners to run, the coaches to coach, and the officials to officiate. [Coaches, parents and spectators have been ejected from meets for not following these rules.]
- 8. Good sportsmanship is one of the values we are to model for our participants. Positive cheering for all runners is encouraged. Remember, today's opponent may be tomorrow's teammate.
- 9. I will set a good example and inform any guest I bring to my child's meet of the Code of Conduct and the requirement to respect other runners, coaches, fans and officials.
- 10. I understand that it is my responsibility to inform any guest or family member that attends my child's meet of the CYO Code of Conduct and that all spectators are to respect all runners, coaches, officials and other spectators at the game.
- 11. I understand that everyone in St. Joseph's CYO is a volunteer, no one is paid. All volunteers are here to see that all children have a positive experience. If at any time, a child or parent has concerns about officials, coaches, runners, opponents, they should first contact their coach, or go to their Athletic Director. Do NOT contact OPPOSING COACHES OR OFFICIALS on the day of the meet. Contact PARISH CYO OFFICIALS.
- 12. Parental Support: We need active parental participation of all parents in our program and our league to make it successful. Please contact us about volunteering for a CYO parish or league position. Coach, Coach Mgr, Equipment Mgr, Uniform Mgr, Treasurer, Scheduler, Awards Mgr, Photo Day Mgr, etc.
